On October 18<sup>th</sup> the NYC Department of Youth and Community Development (DYCD) issued a Request for Proposals for Residential Programs for Runaway & Homeless Youth. DYCD is soliciting proposals from community-based organizations for: one Congregate Care Crisis Shelter, one Apartment Crisis Shelter, and four Transitional Living Programs, one of which will be targeted to special populations. The RFP is available for pickup from 9 to 4:30 weekdays at 156 William Street, 2<sup>nd</sup> Floor, Manhattan. A Pre-Proposal Conference will be held on November 1<sup>st</sup>, from 2 to 4 PM at the same location, 2<sup>nd</sup> floor Auditorium.
